Privacy and Cookie Statement

IXON takes the protection of your privacy very seriously and wants to be transparent regarding how your personal data is collected, processed and shared by us. The personal data that is collected through our services is processed in accordance with the applicable privacy regulations.

This Privacy and Cookie Statement describes your rights and obligations with regard to the process of application and recruitment as provided by the website careers.ixon.cloud.

What data do we collect and how will we use it?

We only collect, store and use personal data that is provided by you (for example via our recruitment form or in a resume attachment) to consider your application and to contact you. We will not use your personal data for any other goals, unless you have given us permission to do so or if we are legally obliged or allowed to do so. Our processing of your personal data is based on our legitimate interest of handling your job application, as stated in article 6 under f GDPR.

Depending on the application data you provide us, different types of data may be processed by us. For example:

- first name;
- last name;
- email address;
- phone number;
- CV or resume;
- photo;
- cover letter;

If the application is considered, we may also process the following data:

- address;
- interview notes;
- (if applicable) the results of a screening, assessment, psychological tests or medical examination;

Furthermore, we process your IP address and location to grant access to the website careers.ixon.cloud, to gain insight in the use of our website and to improve and evaluate our services.

How do we collect your data?

IXON collects your personal data when you:

- visit our website careers.ixon.cloud;
- directly provide your personal data to us (for example, via our application form);
- reply to emails sent from the careers.ixon.cloud platform.

How do we store your data?

Your personal data is only stored in countries within the European Economic Area (EEA). Your data is stored utilizing appropriate security systems and encrypted connections to protect your personal data against loss or any form of unlawful processing. More information about how we secure your

personal data and our platform in general can be found here.

IXON may only share your personal data with third parties if this is permitted by current legislation. We may share your personal data with third parties for the following purposes:

- we contracted them to process certain data;
- it is required for delivering our services to you;
- we are required to do so by law;

The parties that process your personal data on our behalf are IT service providers.

How long do we store your personal data?

We will not store your personal data longer than necessary in order to achieve the purposes as described within this Privacy and Cookie Policy. The personal data you provide to IXON for job application purposes will be retained by IXON for a period of 4 weeks after the end of the application process. If you have given your consent, the data will be stored till 1 year after the end of the application process. When you're hired, the required data will become part of your personnel file.

What are your rights?

You have the right to ask IXON to provide access to information on and access to, rectification, erasure and restriction of your personal data, as well as the right to object to the processing and the right to data portability. Cookies

Disabling of cookies
